## Deafness vs. Hearing Impairment

**Hearing impairment** is describe as loss of hearing in one or both ears. The level of impairment can be mild, moderate, severe or profound

**Deafness** refers to the complete loss of ability to hear from one or both ears.

# Hearing Impairment

### Warning Signs of Hearing Loss

- daydreaming
- inattention
- behavior problems
- lethargy
- failure to follow simple commands
- verbal expression of misunderstanding
- articulation disorders

- limited speech or vocabulary
- difficulty with verbal tasks
- difficulty with phonetic decoding
- persistent colds
- mouth breathing
- unusual voice quality

# School screenings 2006-2007

## 2006

- Grade 1 teachers trained
- 7328 students were screened in Bacolod from 33 schools
- 30% have impacted wax
- 32 students have hearing impairment



## 2007

- 11,384
- (8,884) 20 schools in south of negros
- 2500 in Panay island
- 5 schools in aklan and2 schools in roxas



## Results

- 15% (1805) have impacted wax
- 42 students have hearing impairment
- 38 students need hearing aids
- 3 students have unilateral losses

# Grade of Impairment

Performance with Conversational Voice Test	Grade of Impairment	Corresponding Audiometric ISO Value
Able to hear whispers.	No Impairment	25dB or better
Able to hear and repeat words	Slight	26-40dB
spoken in normal voice at 1 meter.	Impairment	
Able to hear and repeat words	Moderate	41 - 60 dB
using raised voice at 1 meter.	Impairment	
Able to hear some words when	Severe	61 - 80 dB
shouted into better ear.	Impairment	
Unable to hear and understand even a shouted voice.	Profound Impairment	81dB or greater

#### **Pure Tone Audiometry**

- Air Conduction Thresholds the minimum effective sound pressure level of signal that is capable of evoking an auditory sensation
- **Bone Conduction Thresholds** directly stimulate the cochlea

0 - 25	Normal	
26 - 40	Mild	
41 – 60	Moderate	
61 – 80	Severe	
81 & up	Profound

# Pediatric Hearing Evaluation

#### Otoacoustic Emission (OAE)

- > a screening tool that measures the motile activities of the hair cells
- > Assesses auditory function through the level of the cochlea.
- > Acoustic emissions generated by the outer hair cells in the cochlea are elicited by direct acoustic stimulation, and are recorded by a small microphone placed in the ear canal
- > Presence of evoked otoacoustic emissions is correlated with hearing thresholds of 30 dB or better.

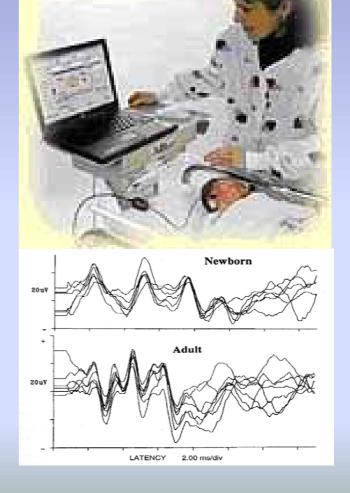


Infants up 2 1/2 vears

 Auditory Brainstem Response (ABR)

➤ usually performed for infants and young children, that evaluates how well sounds travel along the hearing nerve pathways from the ear to the brainstem

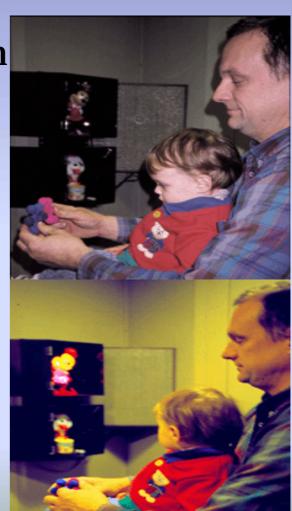
right effective screening tool in the evaluation of suspected retrocochlear pathology such as an acoustic neuroma or vestibular schwannoma



- Behavioral Observation Audiometry (BOA)
  - > assess changes in child's behavior in response to speech and/or tones
  - > Responses suggestive of hearing
  - Motor activity
  - Eye movement toward the source of sound
  - Cessation of activity
  - Crying
  - Startle

## Visual Reinforcement Observation Audiometry (VROA)

- > Assesses hearing acuity using conditioned responses to sound, i.e., head turning. Appropriate for testing children from 7 through 30 months of age.
- > The child is conditioned to provide a specific response to an acoustic stimulus
- > a head turn in the direction of the sound source is rewarded by lighting and/or activating an animated toy.



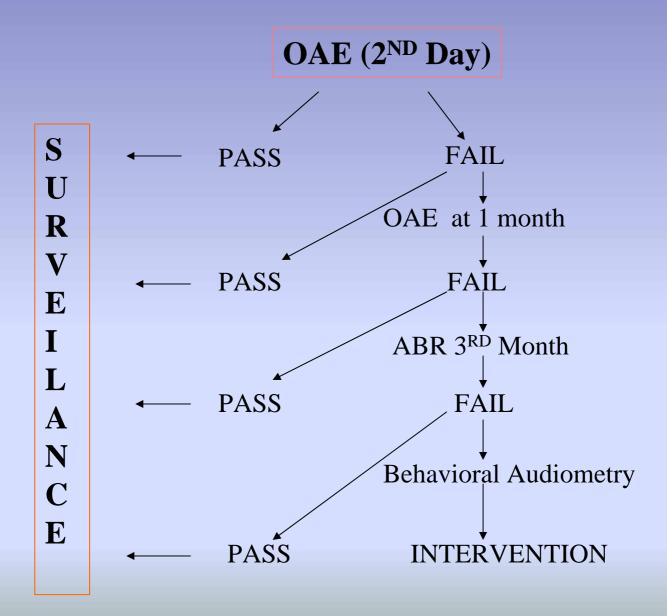
# 3 years old to school age

#### Play Audiometry

> child is conditioned to listen to auditory stimuli

> respond to the sound by participating in a specific play activity (i.e., throwing a block in a bucket, placing pegs in a board, placing rings on a peg, etc.).





## 2006 VECC statistics

- Total of 290 were tested
- 16% (49) Iloilo

Normal hearing - 57% (28)
```

Hearing loss - 39% (19)
```

Unilateral loss - 4% (2)

## 2007 VECC statistics

- Total of 353 were tested
- 17% (62) Iloilo

```
Normal hearing - 35% (22)
```

Hearing loss - 65% (40)

- Ototoxicity
